

ORDINANCE NO. 380

AN ORDINANCE OF THE CITY OF WILLISTON, FLORIDA PROVIDING FOR THE ESTABLISHMENT OF THE WILLISTON COMMUNITY REDEVELOPMENT AGENCY; PROVIDING FOR THE APPOINTMENT AND TERMS OF THE COMMISSIONERS OF THE WILLISTON COMMUNITY REDEVELOPMENT AGENCY; PROVIDING FOR THE REAPPOINTMENT OF COMMISSIONERS OF THE WILLISTON COMMUNITY REDEVELOPMENT AGENCY; RESERVING POWERS TO THE CITY COUNCIL; PROVIDING SUNSET REPEAL; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Williston, Florida did on March 2, 1999, by enactment of Resolution 99-3, make findings regarding the conditions within a Redevelopment Area within the City of Williston and declare the need for a community redevelopment agency, which findings and declaration are incorporated herein by reference; and

WHEREAS, Florida Statutes, Chapter 163, Part III does authorize the City Council of the City of Williston, Florida, as governing body, to establish a community redevelopment agency and to appoint a board of commissioners of the community redevelopment agency;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLISTON, FLORIDA, as follows:

1. The Williston Community Redevelopment Agency is hereby established and is vested with all of the powers, duties, responsibilities and obligations as provided in Florida Statutes, Chapter 163, Part III.

2. The City Council shall appoint seven commissioners of the Williston Community Redevelopment Agency, the redevelopment agency of the City of Williston, Florida, existing under the authority of Florida Statutes, Chapter 163, Part III, with initial terms of office as follows:

1	March 16, 2000
2	March 16, 2001
3	March 16, 2002
4,5,6 & 7	March 16, 2003

3. After the initial terms of appointment have expired, successor commissioners shall be appointed by the City Council and will hold office for a term of four years.

4. The City Council of the City of Williston, Florida reserves unto itself the powers set forth in Florida Statutes Section 163.358 and all other powers, duties and responsibilities as may be set forth in Florida Statutes, Chapter 163, Part III.

5. Unless specifically re-enacted by resolution of the City Council prior to March 16, 2001, this ordinance shall stand repealed as of that date, and the Williston Community Redevelopment Agency shall be terminated.

6. This Ordinance shall take effect on April 16, 1999, or on such earlier date as it is signed by the Mayor.

Enacted by the Williston City Council at the conclusion of a properly advertised public hearing, this 16th day of March, 1999.
