WHEREAS, the City of Williston from time to time requires the establishment of a Charter Review Committee; and

WHEREAS, the Mayor and City Council believe it is in the best interest of the City that the Charter to be reviewed in its entirety by representative citizens of the City; and

WHEREAS, the Mayor and City Council believe the study of the existing Charter should be a deliberate, thoughtful, and inclusive process; and

WHEREAS, the Mayor and City Council after due study and deliberation have determined that it is in the best interest of its residents to establish a Charter Review Committee whose mission is to solicit citizen input, deliberate with due care, prepare a report with recommendations, and deliver that report to the Mayor and City Council; and

WHEREAS, this ad hoc committee shall be solely advisory to the City Council and shall serve by appointment of the Mayor and City Council; and

NOW, THEREFORE, BE IT RESOLVED BY THE PEOPLE OF THE CITY OF WILLISTON, FLORIDA:

<u>Section 1</u>: The City Council hereby establishes a Charter Review Ad Hoc Committee. The Charter Review Committee shall serve as an advisory board to the City Council and all reports and recommendations are subject to the approval of the City Council.

Section 2: The Charter Review Committee shall be composed of seven (7) city residents of the City of Williston, to be appointed by the City Council in the following manner: The Mayor and each City Councilmember shall appoint one (1) person to said committee, and as a Council shall appoint one (1) additional member at large, to reflect a cross section of the City.

<u>Section 3:</u> The Charter Review Committee has the following duties and responsibilities:

a) To review and evaluate the City Charter in its entirety

- b) To solicit citizen input regarding these issues by public forums or other processes.
- c) To prepare a final report and deliver it to the Mayor and City Council, setting forth the findings, recommendations, and any proposals for amendments to the Charter.

Section 4: There is hereby appointed by the Mayor and City Council and ratified by this Resolution, the following appointments to the City of Williston Charter Review Committee:

Said appointment term shall terminate upon the completion of the task of Charter Review Committee as directed by the City Council.

Section 5. All resolutions or parts of resolution to the extent of conflict herewith are hereby repealed.

Section 6. This Resolution shall take effect immediately upon its adoption.

BACKGROUND / DESCRIPTION:

The property has been in a state of disrepair for many years and has been found guilty of violations of the City of Williston Municipal Code. Additionally, a daily fine has been imposed that is yet to be paid. The fees due are now up to \$22,900 and the City is ready to move forward with foreclosure on this property. Order to Correct was filed 12/28/2021. Three months expired 3/28/21. Current lien is \$31,000. To foreclose it will cost approximately \$2,700 in legal fees and title search, provided there are no additional attorney's fees.

TOPIC: MAGISTRATE FOR CODE ENFORCEMENT

REQUESTED BY: LAURA JONES, CITY PLANNER

BACKGROUND / DESCRIPTION:

The City of Williston staff would like to update the Land Development Code of Ordinances to allow for a Special Magistrate to hear Code Enforcement cases. Cities all over Central Florida are moving in this direction for the following reasons:

- 1. No quorum necessary.
- 2. Paid through fees and fines collected but do not reduce the amount collected by the City. This is allowed by Florida Statute.
- 3. Emergency hearings are easier when needed for life-safety reasons.
- 4. Decisions are non-biased, quick and binding.
- 5. Case preparation only requires a description.
- 6. They can handle a high volume of work more efficiently.

Reasons specific to Williston include:

- 1. Difficulty filling Boards. The Code Enforcement Board has been under filled for over a year and has received no applications from citizens wishing to serve. By the end of the year, Planning & Zoning Board will have at least two vacant seats. We have had a very difficult time filling the Citizens Task Force Committee for CDBG grants.
- 2. Difficulty communicating with Boards through email and phone calls. There would be only one person to coordinate.
- 3. Meetings are "rushed" due to volunteers having other obligations.
- 4. Fines typically begin 30 days after hearing. This is after the Officer had been working with the property owner at least 30 days due to meetings being monthly.
- 5. Property owners are not taking the City seriously.
- 6. City is paying attorneys to assist the Code Enforcement out of the City budget.

LEGAL REVIEW:

Attorneys have been informed. No additional legal review was required. We will still need their services regarding

RECOMMENDED ACTION:

Staff recommends allowing the Land Development Code to be revised to allow for a Special Magistrate. This process will be by Ordinance with Public Hearings therefore citizens will have time to review and give input.

Discussion and possible action to approve the City Council President to sign an Initial Order (Agreement) between the City of Williston, and RingCentral, Inc. The scope of this agreement is for RingCentral to provide Voice Over IP (VOIP) telephone services to the city.

A migration from existing telephone services to VOIP services will provide vastly improved communications for the entire city operations, including City Hall, Police Department, Fire Department, Airport, and other outlying City facilities. The VOIP system will provide more functionality, and will replace several independent systems currently in place.

The VOIP services will also provide enhance communications among departments, employees, and customers. The monthly costs of this service are about \$20 per month less than what we are currently paying CenturyLink, (Approximately \$1,600.00).

We will also be able to eliminate the approximately \$785.00 per month that we currently pay to SunCom. We can eliminate the annual amount we pay for GoToMeeting, as the video conference is included in this contract, for an additional savings of \$192.00 / year.

The initial cost of equipment (Telephones, POE Switches, Ethernet Cable, RJ45 Connectors, etc.) to be purchased will around \$7,600.00._The savings of elimination of the Suncom bill will result in a budget surplus of about \$1850.00 in 1 year. The savings of elimination of the GoToMeeting bill will result in a budget surplus of about \$192.00 in 1 year.

In addition, the plan is eventually going to eliminate most of the City provided cell phones, and another savings of around \$1,500.00 per month.
