Council Meeting Procedures for members of the Public

- 1. All cell phones to be turned off when entering the Council Chambers.
- 2. Once the audience has taken their seat and the meeting begins, there will be no talking between audience members during the course of the Council meeting. If anyone continues to talk within the audience and is called down 3 times during the course of the meeting, on the third time that person will be escorted out of the Council meeting;
- 3. The audience must be recognized by the President before being allowed to address the Council;
- 4. The member of the audience that is recognized will proceed to the podium, state their name for the benefit of the City Clerk, prior to offering comments on a given matter.
- 5. The audience member will be limited to not more than 5 minutes to speak based on Resolution 2012-07;
- 6. There will be no personal attacks made by any member in the audience toward a sitting Council member and no personal attacks made by any Council member toward a member of the audience;
- 7. There will be no conversation between a member of the audience that has been recognized and any other member of the audience when speaking while at the podium;
- 8. If an audience member wants to speak more than the allotted 5 minutes allowed then that person should make a request to City Hall so that the item may be placed on the agenda.

Minutes of the City Council meeting may be obtained from the City Clerk's office. The minutes are recorded, but not transcribed verbatim. Persons requiring a verbatim transcript may make arrangements with the City Clerk to duplicate the recordings, or arrange to have a court reporter present at the meeting. The cost of duplication and/or court reporter will be borne by the requesting party.

In accordance with <u>Section 286.0105</u>, Florida Statutes, notice is given that if a person wishes to appeal a decision made by the City Council with respect to any matter considered at this meeting they will need a record of the proceedings, and for such purpose may need to ensure that a verbatim record of the proceeding is made, which record includes the testimony and evidence upon which the appeal is based.

In accordance with <u>Section 286.26</u>, Florida Statutes, persons with disabilities needing special accommodations to participate in this meeting should contact the Mayor through the City Clerk's office no later than 5:00 P.M. on the day prior to the meeting.

Market summary

- The clinical market has now evolved to require the provider to demonstrate the ability to serve multiple client behavioral issues i.e. substance abuse AND mental health.
- Demonstrating the ability to provide these multitude of services has not happened at a rate fast enough to keep up with the need, as reported by the Florida Behavioral Health Association 61.7% of adults with Any Mental Illness (AMI) in Florida did not receive treatment; National Average 55.8%
- At OakTree Addiction & Recovery LLC, we believe that we can provide services that will fill this market gap.
- According to Florida Department of Health, suicide counts are higher than homicides in 56 of Florida's 67 counties. 84%of the State experienced more suicides than homicides in 2020.
- At Levy County alone suicides exceeded homicides by 300%. The table on the next slide shows a complete breakdown by county.

Access to Care Ranking vs Adult Incarceration Rates

• In 2015, The Sentencing Project ranked the states based on the number of people incarcerated in state prisons per 100,000 residents.



- Comparing state-by-state rates of incarceration with the access to mental health care ranking shows a strong positive correlation between rates of adult who are in the criminal justice system and lack of access to mental health care.
- 6 out of the 10 states with the least access to mental health care also have the highest rates of incarceration:



Market Summary – Florida Substance Abuse Stats

- Florida's rate of drug abuse and drug-related deaths is higher than the national average and there are about 3,000 deaths per year from drug use. In fact, there are more drug-related deaths in the state than there are deaths by gun violence or car accidents.
- Approximately 8% (or 1.5 million) of Floridians are using illicit drugs at any given point in time.
- 7,579 people died from a drug overdose in Florida, making Florida number two in the nation for overdose deaths behind only California. This number is a 37% increase from 2019.
- Florida's opioid overdose death rate has tripled since the year 2000 and the number of accidental drug overdose deaths more than doubled between 2014 2016.





Project Proposal

Our proposal is to convert the former middle school in Williston, Florida into a state-of-the-art medical facility providing inpatient & outpatient addiction and mental health treatment.

Not only will we give our patients a second chance in life but also reinvigorate the former school building and support the local community through our employment & engagement program.

Service Offering

The Company

- Oaktree Addiction & Recovery, LLC. provides clinical services for substance abuse and mental health. The following modalities are specialized to target addictions and co-occurring disorders.
- It is our belief that substance abuse disorders impact the entire family. An individual may experience binge use to severe dependency and can be brought into remission through conscious decisions and focused behavior changes on the part of our clients. We view chemical dependency and other addiction disorder as an illness, which if left untreated, can be progressive and often fatal. Our multidisciplinary team is highly trained in the areas of medical, psychological, and addiction. Our professional team will provide a safe and trusting experience.
- Our program is designed to provide a supportive and solution-oriented therapeutic process tailored to the individual. Treatment
 intensity, focus, and length will be proportionate with the client's needs. The overall goal of the program is to provide a safe therapeutic
 environment that encourages and promotes recovery. Our program strives to provide a degree of flexibility to meet the individual needs
 of the patient.
- Oaktree Addiction & Recovery, LLC believes that detoxification involves much more than simply medically withdrawing a patient from alcohol or other drugs. Detoxification, whether done on an inpatient, residential, or outpatient basis, is the initial therapeutic encounter between patient and clinician. Our facility will provide a comprehensive program that follows on from medical detox to inpatient treatment, Partial Hospitalization, Intensive Outpatient and Outpatient treatment. Irrespective of the substance involved, a detoxification episode should provide an opportunity for biomedical (including psychiatric) assessment, referral for appropriate services, and linkage to treatment services.
- Inpatient Medical Detoxification is the responsibility of medical team, medical director and quality assurance risk management team.

Where do our patients come from?

- We expect our patients to come from the following sources:
 - > Referral Source: This would involve Physicians, Hospitals and Treatment Facilities / Agencies.
 - Individuals and Families: Patients would contact us through our digital market channels or by hearing about us through personal contacts
 - > Managed Care Companies and Single County authorities
- At the end of the treatment period we expect our patients to return to their county of domicile either within Florida or outside Florida.

Employment and Community Engagement Program

- Once the site is fully operational, we expect to have at least **50 employees** to support our operation. This would make us one of the major employers in East Williston alongside the tax revenue that will be generated from a financially stable organization.
- Furthermore, we agree to budget USD 100,000 as a donation to the City for the phased construction of the community park which should include a basketball court.
- Should we establish our roots here then we would want to have a long-term engagement with the community in the shape of an athletic sponsorship program and / or other initiatives that we might take in the future.
- Our site will be secure and fenced that blends into the local environment and is architecturally palatable. We are happy to consult and incorporate the views of the City on this matter.
- We would reassure the community that the residents of our facility are medically vulnerable patients that have mostly come through professional medical referrals. Admission is voluntary. We are **not** building a detention center for housing criminals.
